

**Resolution 2017-16**  
**Surplus Equipment and Asset Deletion/ Parks and Waterways**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

**WHEREAS**, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

**WHEREAS**, *Idaho Code* §31-808 provides that property classified as being under \$250.00 may be sold through a private sale without notice of public auction; and

**WHEREAS**, Kootenai County Parks and Waterways has on its asset list one (1) 1980 2-Ton Chevrolet Flatbed truck, Asset #3353; Serial #C18DEAV116256 and one (1) 1963 telephone pole trailer, Asset #3552 which have outlived their useful life for the Parks & Waterways Department; and

**WHEREAS**, the equipment/vehicle described hereinabove are in poor condition, and have been offered to other County departments pursuant to the Excess Personal Property Policy; and

**WHEREAS**, Kootenai County Parks and Waterways desires to have the above-referenced items declared as surplus property, disposed of pursuant to law, and removed from the County's asset list;

**NOW THEREFORE, IT IS HEREBY RESOLVED** that the items referenced hereinabove be, and hereby are, declared to be surplus property, and in accordance therewith, the Board of County Commissioners directs staff to offer the 1963 telephone pole trailer to the four (4) highway districts prior to disposal of said items by public or private sale, or by another means, in accordance with Idaho law and remove the same from the County's list of assets.
