

Resolution 2017-89
Transfer Surplus Shotguns/Kootenai County Sheriff

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County, and

WHEREAS, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

WHEREAS, the Kootenai County Sheriff's Office has in its possession three (3) Remington 870 Shotguns, bearing serial numbers V497273V, V642421V, and, V614461V, all of which have outlived their useful life and functionality for the current needs of law enforcement; and

WHEREAS, the three shotguns referenced hereinabove were acquired around 1978-1979 and have been utilized by law enforcement for nearly 40 years; and

WHEREAS, the three shotguns were inspected by a certified armorer and found to be in fair condition, and each has an estimated present appraisal value of \$200; and

WHEREAS, the Kootenai County Airport staff has expressed an interest in obtaining the shotguns, and after being altered and equipped with special noise making devices, could utilize the same as aids in keeping the birds off airport runways; and

WHEREAS, the shotguns are of no further use to law enforcement, and it is therefore the recommendation of the Kootenai County Sheriff's Office that the shotguns be declared as surplus and transferred to the Kootenai County Airport.

NOW THEREFORE, IT IS HEREBY RESOLVED that the three shotguns described hereinabove be, and hereby are, declared as surplus property, and that the same be removed from the asset list of the Kootenai County Sheriff's Office and transferred to the asset list of the Kootenai County Airport.

BE IT FURTHER RESOLVED that the Kootenai County Sheriff's Office is to make arrangements directly with Kootenai County Airport staff for the transport and delivery of the shotguns on a date and time mutually convenient.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Bingham, seconded by Commissioner Fillios, the following vote was recorded:
