

**Resolution 2014-92  
Setting Fees for Responses to Public Records Requests  
Per Idaho Code § 9-338**

**WHEREAS**, Idaho Code § 9-338 acknowledges the right of every person to examine and take copies of the public records of any public agency in the State of Idaho except as provided by law; and

**WHEREAS**, County staff often receive requests from the public for copies of public records within the County's custody and possession; and

**WHEREAS**, the County's response to these requests often requires a substantial amount of staff time in addition to the costs directly associated with the response; and

**WHEREAS**, the Kootenai County Board of Commissioners ("Board") desires to provide the most efficient customer service possible, and believe that establishing consistent guidelines for County departments increases the County's ability to provide this service; and

**WHEREAS**, the Board is authorized under Idaho Code § 9-338 to set fees related to locating, copying and disseminating public records in order to help defray associated costs; and

**WHEREAS**, the Board acknowledges that certain County offices and departments, such as the District Court, the Recorder's Office, and the Sheriff's Office, have fee structures which are set forth in, or authorized by, other provisions of Idaho statutes or court rules; and

**WHEREAS**, all other County offices and departments are governed by the provisions of Idaho Code § 9-338;

**NOW, THEREFORE, BE IT HEREBY RESOLVED** that, except as otherwise provided in Idaho statute or court rule, the following fees for responses to public records requests shall become effective as of the date of this Resolution:

**BE IT FURTHER RESOLVED** that the fees set forth in this Resolution shall be paid at the time of the service provided unless otherwise approved by the appropriate elected official or department head.

**BE IT FURTHER RESOLVED** that the fees set forth in this Resolution shall be waived if the requesting party meets all of the criteria set forth in Idaho Code § 9-338(10)(f), and may be waived by the appropriate elected official or department head if he or she finds that such waiver would be in the public interest.


**BE IT FURTHER RESOLVED** that Resolution No. 2012-13, adopted on March 20, 2012, is hereby repealed and shall have no further force or effect.


