

**Minutes of Meeting**  
**Requests for Cancellation of Taxes**

The Kootenai County Board of Commissioners: Chairman Marc Eberlein, Commissioner Chris Fillios and Commissioner Bob Bingham met to discuss the following agenda items. Also present were Chief Deputy Treasurer Laurie Thomas, Civil Deputy Prosecuting Attorney R. David Ferguson, BOCC Administrative Secretary Teri Johnston and Deputy Clerk Tina Ginorio. Also present was Kootenai County Resident Chris Carlson.

- A. Call to Order:** Chairman Marc Eberlein called the meeting to order at 9:32 a.m.
- B. Changes to the Agenda (Action):** There were no changes to the agenda.

**Request for Cancellation of fees/AIN 229204/Carlson**

Kootenai County Resident Chris Carlson was sworn in by Deputy Clerk Tina Ginorio.

Mr. Carlson explained that he put his tax payment into the drop box in front of the Coeur d'Alene Department of Motor Vehicles office on June 20, 2018. He said he was under the impression this was an acceptable spot to put it but he was notified a month later that his tax payment had not been received until July 2, 2018 and he was assessed interest and late fees.

Chairman Eberlein asked Chief Deputy Treasurer Laurie Thomas to confirm the due date of the taxes. She said it was June 20, 2018 and stated her office did not receive the envelope until July 2, 2018.

Commissioner Chris Fillios reminded those assembled that there had been a problem with other tax payments being put in that drop box. He said improved signage had recently been placed on the drop box to rectify this.

Commissioner Fillios moved that the Board approve Mr. Carlson's request to have the interest and late fees to AIN 229204 cancelled. Commissioner Bob Bingham seconded the motion. There being no further discussion, Deputy Clerk Ginorio called the roll:
