

Minutes of Meeting
Requests for Cancellation of Taxes
November 7, 2018
9:30 a.m.

The Kootenai County Board of Commissioners: Chairman Pro Tem Chris Fillios and Commissioner Bob Bingham met to discuss the following agenda items. Also present were Chief Deputy Treasurer Laurie Thomas, Civil Deputy Prosecuting Attorney R. David Ferguson, BOCC Administrative Secretary Teri Johnston and Deputy Clerk Tina Ginorio. Chairman Marc Eberlein was excused.

- A. Call to Order:** Chairman Pro Tem Chris Fillios called the meeting to order at 9:33 a.m.
- B. Changes to the Agenda (Action):** There were no changes to the agenda.
- C. Action Items:**

Request for cancellation of fees/AIN 164857/Wood

Chief Deputy Treasurer Laurie Thomas explained that the property owner asked for a cancellation of late charges and interest because the tax payment check was lost in the mail. She added that the property owner asserted, in error, that the taxes had never been paid late before.

Commissioner Bob Bingham moved that the Board deny the request for cancellation of late fees and interest on AIN 164857. Chairman Pro Tem Fillios seconded the motion. There being no further discussion, Deputy Clerk Ginorio called the roll:

The motion carried.

Request for cancellation of fees/AIN 138342/Wilson

Ms. Thomas explained that this property owner's late charges and interest on one parcel had been cancelled in an October 2018 meeting because he had placed his payment in good faith, but in error, in the deposit box for the Department of Motor Vehicles. She listed the item as Resolution 2018-88. Ms. Thomas said that, when the documents were reviewed in her office, she discovered that he had actually paid the taxes on two properties with the single mis-delivered check. She suggested that the Commissioners' intent may have been for all affected properties to have the interest and late fees removed and asked if they wished to pass an additional motion for the second parcel for consistency's sake.

Commissioner Bingham moved that the Board approve the request for cancellation of the late charges and interest on AIN 138342, in the amount of \$10.87. Chairman Pro Tem Fillios seconded the motion. There being no further discussion, Deputy Clerk Ginorio called the roll:

The motion carried.
