

RESOLUTION NO. 2010-99

Solid Waste Fees

WHEREAS, Title 31, Chapter 44 of the Idaho Code allows counties to charge fees for use of the County Solid Waste Disposal system; and

WHEREAS, the Kootenai County Solid Waste Ordinance authorizes establishment of said fees by resolution duly adopted by the Board of County Commissioners; and

WHEREAS calculations of assessed solid waste fees will be rounded using established accounting rounding guidelines to whole dollar amounts; and

WHEREAS, the fees to be charged should conform to the costs established for the solid waste system by budget adopted by the Board of County Commissioners.

NOW, THEREFORE, BE IT RESOLVED, Resolution No. 2009-72 is rescinded, and

FURTHER, the following fees are established on an annual or unit basis for fiscal year 2009/2010 and shall increase by 2.5% bi-yearly (every two years) or until replaced by resolution.

SECTION 1: Solid Waste Increments

Residential Unit	\$ 93.00 (per unit) (Normally up to four dwellings in combination of singles to four-plex. An exception to the commercial rule is made when there are multiple residential units on a parcel that all take individual residential garbage service, e.g. several tri-plexes etc.)
Uninhabitable Structure	no fee
New Occupancy	Monthly prorate= $\frac{\text{annual fee}}{12}$
Commercial Unit	\$350.00 (Commercial w/out garbage service or any residential unit in excess of four; minimum commercial unit will be ¼ full unit)

SECTION 3: TERM AND PAYMENT

Annual fees are billed on the consolidated tax statement. Fees for operation of the solid waste system are to be billed in advance of the services rendered so the solid waste system can operate on a cash basis in accordance with the Idaho Constitution. No fee shall be charged to un-occupiable dwellings. Conditions necessary to qualify for solid waste fee reductions are stated in the current "Circuit Breaker Resolution".

Upon payment of the annual fee, the residential property owner is authorized to dispose of up to 2,000 lbs of ordinary household wastes and yard debris associated with the residential property which the fee was paid without additional charges at the Solid Waste Department, excluding roofing, demolished buildings or trailers and those items identified herein. Ordinary household waste with additional exclusions posted at each rural site may also be disposed of at the remote (dumpster) sites located throughout the rural portions of the County. Commercial use of these rural disposal sites is prohibited.
