

RESOLUTION 2019-10
INCREASE OF NIGHTTIME WATERWAYS SPEED LIMIT

WHEREAS, Section 67-7031(3), Idaho Code, authorizes the boards of county commissioners of each county in Idaho to adopt local ordinances with reference to the operation of vessels on any waters within its territorial limits, provided said ordinances are intended to promote or protect the health, safety, and general welfare of its citizenry; and

WHEREAS, the Kootenai County Board of Commissioners has adopted the *Kootenai County Parks and Waterways Ordinance*, Kootenai County Code, Section 6-2-1, *et seq.*; and

WHEREAS, the *Kootenai County Parks and Waterways Ordinance* provides for the codification of resolutions adopted by the Board of Commissioners as an appendix to the ordinance, Kootenai County Code, Section 6-2-21; and

WHEREAS, the *Kootenai County Parks and Waterways Ordinance* provides that the nighttime vessel speed limit, unless otherwise restricted, not exceed twenty (20) miles per hour pursuant to Kootenai County Code, Sections 6-2-4(B)(3) and 6-2-4(C)(2); and

WHEREAS, the Kootenai County Sheriff and the Director of the Kootenai County Parks and Waterways Department have recommended amending Kootenai County Code, Sections 6-2-4(B)(3) and 6-2-4(C)(2), increasing the nighttime vessel waterways speed limit to not exceed twenty-five (25) miles per hour; and

WHEREAS, the Board of County Commissioners concurs with the recommendations of the Kootenai County Sheriff and the Director of the Kootenai County Parks and Waterways Department.


NOW THEREFORE, BE IT HEREBY RESOLVED that the nighttime vessel speed limit identified hereinabove shall be amended and increased to not exceed twenty-five (25) miles per hour; and that said amendment be codified as an appendix to the *Kootenai County Parks and Waterways Ordinance* pursuant to Section 6-2-21, Kootenai County Code.

Upon motion to adopt the text of the foregoing Resolution made by Commissioner Duncan and seconded by Commissioner Brooks, the following vote was recorded:




Notice of Public Hearing


