**THE ADOPTION OF THE UNIFORM SYSTEM FOR THE QUALIFICATION & APPROVAL FOR
PERFORMANCE OF EVALUATION PURSUANT TO IDAHO CODE §18-918**


WHEREAS Idaho Code §18-918 and Idaho Criminal Rule 33.3 require that any person who pleads guilty or is found guilty of domestic battery, domestic assault and/or attempted strangulation shall undergo, at the person's own expense, an evaluation by a person, agency, or organization approved by the court to determine whether the defendant should be required to obtain counseling or other appropriate treatment.

WHEREAS the Idaho Supreme Court has established through ICAR 75 a uniform system for the qualification and approval of a person, agency, and/or organization to perform the evaluations required and only those approved by the Court shall be authorized to conduct such evaluations.

IT IS HEREBY ORDERED that the First Judicial District hereby adopts as its own the Supreme Court uniform system which can be located at: <https://isc.idaho.gov/domestic-assault-or-battery-evaluators-roster-search-results>.

IT IS FURTHER ORDERED that Administrative Order C95-DW.4 is rescinded.
