DISASTER EMERGENCY DECLARATION
East Side Highway District Culvert Failure
March 15, 2025

WHEREAS, the East Side Highway District has adopted its Declaration of Emergency 2025-02 on March 11, 2025, as a result of the Fourth of July Creek's flooding and partial collapse of the culverts under River Road, and has requested that Kootenai County adopt a disaster declaration for said reason pursuant to Idaho Code §46-1011; and

WHEREAS, the East Side Highway District has concerns of a full failure and washout of the culverts when the Coeur d'Alene River rises due to imminent spring runoff; and

WHEREAS, the resources of the East Side Highway District are being exhausted and costs of repair are estimated by the East Side Highway District at \$300,000.00 to \$500,000.00; and

NOW, THEREFORE, BE IT RESOLVED and declared by the Kootenai County Board of Commissioners, pursuant to the authority granted in Section 46-1011, Idaho Code, as follows:


1. A disaster emergency exists within Kootenai County, resulting from existing and imminent danger to structures, infrastructures, public utilities, private and public property and/or human life.
2. Such disaster emergency may require state assistance to supplement local emergency management efforts to provide for public safety and the protection of property and to avert and lessen the threat and impact of the disaster.
3. The Kootenai County Board of Commissioners requests that the governor of the State of Idaho, together with other appropriate state officials, as necessary, make such declarations, and provide assistance within Kootenai County, as is required and allowed by law.
