

Resolution 2024-46
**Surplus Property/Transfer to State of Idaho/
Asset Deletion/Transit Department**

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County, and

WHEREAS, *Idaho Code* §31-808 provides that the board of county commissioners may at their discretion, grant to or exchange with the State of Idaho, with or without compensation, any personal property owned by the county, after adoption of a resolution by the board of county commissioners that the grant or exchange of property is in the public interest; and

WHEREAS, the Kootenai County Transit Department has a motor vehicle on its Asset List which is not being used, is obsolete and/or fully depreciated, and therefore is of no further use to the County; and

WHEREAS, this motor vehicle is described as One (1) 2016 Chevrolet Express Cutaway 4500 6.0 6L V-8 Elkhart Coach ECII Bus, VIN#1GB6GUBG8G1317590, with 169,566 miles;

WHEREAS, the State of Idaho, Division of Veterans Services, has expressed interest in using the bus to transport veterans requiring transportation for medical appointments and other basic needs; and

WHEREAS, notice of this proposed transfer was published in the *Coeur d'Alene Press* on April 24th, 2024; and

WHEREAS, the Kootenai County Transit Department desires to have the above-described motor vehicle removed from the County's asset list;

NOW THEREFORE, IT IS HEREBY ORDERED that the above-described motor vehicle shall be disposed of as set forth above and shall be removed from the County's list of assets.
