

Resolution 2024-63
Solid Waste Fee Resolution
Superseding Resolution 2019-74

WHEREAS, Title 31, Chapter 44, *Idaho Code*, authorizes Kootenai County to charge fees for the use of the County's Solid Waste Disposal System; and

WHEREAS, the Kootenai County Board of Commissioners (hereinafter referred to as "the Board"), pursuant to Kootenai County Code §4-3-7, is authorized to adopt and implement rules necessary for the operation of the county solid waste system via the adoption of resolutions; and

WHEREAS, the Board has most recently adopted the Solid Waste Fee Resolution, Resolution No. 2019-74, effective January 1, 2020, and, pursuant to Kootenai County Code §4-3-6, the Board may at any time amend said Fee Resolution to accommodate changes in the fee system and the Solid Waste Department's operating policies; and

WHEREAS, the Kootenai County Solid Waste Department has recommended an amendment to the Solid Waste Fee Resolution, providing for an increase in fees to conform with the costs established for the solid waste system by the budget adopted by the Board of County Commissioners; and

WHEREAS, calculations of assessed solid waste fees are rounded using established accounting rounding guidelines.

NOW THEREFORE, IT IS HEREBY RESOLVED, that Resolution 2019-74 is rescinded, and

BE IT FURTHER RESOLVED, the following fees are established and effective on January 1, 2025.

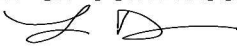
