

**Resolution 2024-70
Kootenai County Waterways Ordinance, Increase of Fees**

WHEREAS, Sections 31-870 and 63-1311, Idaho Code, provide that the boards of county commissioners of each county in Idaho may collect fees for the services provided; and

WHEREAS, it is the responsibility of the Kootenai County Board of Commissioners, pursuant to Idaho Code §31-807, to manage the use of facilities owned by Kootenai County, which provide access to waterways and recreational opportunities; and

WHEREAS, Kootenai County Code 6.2.116(D) sets forth the authority of the Kootenai County Board of Commissioners to implement fees for the non-commercial use of county facilities; and

WHEREAS, the Kootenai County Waterways Advisory Board has recommended the following fee increases:
