

RESOLUTION NO. 2024-76

DONATION OF PERSONAL PROPERTY TO BOUNDARY COUNTY

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* §67-2322 provides that counties have the power to convey or transfer personal property to another unit of government, with or without consideration, and that such conveyance or transfer may be made without consideration or payment when it is in the best interest of the public in the judgment of the Board of County Commissioners; and

WHEREAS, the Kootenai County Sheriff's Office (hereinafter the "Sheriff") has in its possession the following personal property:

2005 Polaris RMK 700, with serial # SN1NL7CS35C544336, and asset # 3943 worth about \$1,155
2006 Polaris RMK 700, with serial # SN1PL7HS06C637821, and asset # 4196 worth about \$1,380
2000 Yacht Club Trailer, with VIN #4H101181XY069659, and unknown asset#, worth about \$800

; and,

WHEREAS, the above referenced personal property is of no use to Kootenai County; and,

WHEREAS, Boundary County, through the Boundary County Sheriff's Office, provides law enforcement services in Boundary County, Idaho, and desires to use the above referenced personal property for law enforcement activities; and,

WHEREAS it is the desire of Kootenai County to donate the above-referenced personal property to Boundary County, and the desire of Boundary County to accept the personal property for law enforcement activities.

NOW THEREFORE, IT IS HEREBY RESOLVED that the personal property referenced hereinabove be, and hereby is, declared to be surplus property, and that in the judgment of the Board of County Commissioners it is in the best interest of the public to donate the same to Boundary County.

IT IS FURTHER RESOLVED that the Board of County Commissioners hereby donates the following described personal property to Boundary County for law enforcement activities:

2006 Polaris RMK 700, with serial # SN1PL7HS06C637821, and asset # 4196 worth about \$1,380
2000 Yacht Club Trailer, with VIN #4H101181XY069659, and unknown asset#, worth about \$800
