

Resolution 2024-80
Adopt Kootenai County Personnel Policy Manual Revision

WHEREAS, the Kootenai County Board of Commissioners adopted the Kootenai County Personnel Policy Manual dated November 29, 2016; and,

WHEREAS, the Kootenai County Board of Commissioners finds it necessary, from time to time, to make amendments to certain policies in the Kootenai County Personnel Policy Manual in order for Kootenai County to comply with changes in the law and/or governing regulations, and/or to implement necessary policies to ensure that Kootenai County maintains an established safe and cooperative working environment; establishes responsibilities and levels of performance expected of County employees; and, explains the benefits Kootenai County offers and provides to its employees; and,

WHEREAS, the Kootenai County Board of Commissioners determined it was necessary to revise Policy 600, Job Evaluation/Classification, to document the process by which the Human Resources Department of Kootenai County evaluates employment positions which have changed due to organizational changes and/or the development of new processes or technology resulting in changes to the requirements of a specific position; and,

WHEREAS, with the cooperation and assistance of Sylvia Proud, Director of Kootenai County Human Resources, and Darrin L. Murphey, Kootenai County Civil Deputy Prosecuting Attorney, a proposed revision to Policy 600 – Job Evaluation/Classification was prepared and presented in a public meeting before the Kootenai County Board of Commissioners on September 19, 2024, and the proposed revision was approved by the Kootenai County Board of Commissioners at said public meeting. A copy of the revised Policy 600 – Job Evaluation/Classification is attached hereto as Exhibit “A” and incorporated herein.

NOW THEREFORE, IT IS HEREBY RESOLVED that the Kootenai County Board of Commissioners does hereby adopt the revised Policy 600 – Job Evaluation/Classification Policy and Procedure as referenced hereinabove and incorporates the same into the Kootenai County Personnel Policy Manual effective October 15, 2024.


