

**Resolution 2024-95
Surplus Equipment/Solid Waste**

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* §31-829 provides that whenever any elected official has any property belonging to the county under his/her jurisdiction or control which, in his/her judgment is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

WHEREAS, the Kootenai County Solid Waste Department is in possession of the following equipment:

WHEREAS, the equipment described hereinabove is valued in excess of \$250.00, and has not been offered to other county departments because the equipment is specified for Solid Waste department needs; and

WHEREAS, the Kootenai County Solid Waste Department desires to have the equipment declared as surplus property, deleted from its asset list, and disposed of;

NOW THEREFORE, IT IS HEREBY RESOLVED that the items referenced hereinabove be, and hereby are, removed from the County's list of assets and declared to be surplus property, and in accordance therewith, the Board of County Commissioners may take action to dispose of said items by public sale in accordance with Idaho law.
