

**Resolution No. 2021-06  
DISASTER EMERGENCY DECLARATION  
Kootenai County Windstorm  
January 14, 2021**

WHEREAS, a powerful windstorm has caused large-scale damage throughout Kootenai County; and

WHEREAS, certain power outages resulting from the windstorm are expected to remain for several days or longer; and

WHEREAS, the results of this windstorm are creating an imminent threat to structures, infrastructures, public utilities, private and public property and/or human life within Kootenai County; and

WHEREAS, government and private entities are being taxed in order to provide emergency management services to those areas affected by this windstorm; and

WHEREAS, Kootenai County does not have access to resources to respond to said effects of the windstorm; and

WHEREAS, the chairman of a Board of Commissioners may declare a disaster emergency on behalf of the County for seven (7) days as stated in Section 46-1011, Subsection 1, Idaho Code; and

WHEREAS, Chris Fillios, Chairman of the Kootenai County Board of Commissioners, found that a disaster emergency, as those terms are defined in Section 46-1002, Idaho Code, was in existence on January 13, 2021, in Kootenai County, which local county and private resources were being taxed to control, and that State assistance was requested, pursuant to Title 46, Chapter 10, Idaho Code, and other state laws pertaining to disaster, emergencies and assistance;

NOW, THEREFORE, BE IT RESOLVED and declared by the Kootenai County Board of Commissioners, pursuant to the authority granted in Section 46-1011, Idaho Code, as follows:


1. A disaster emergency exists within Kootenai County, resulting from existing and imminent danger to structures, infrastructures, public utilities, private and public property and/or human life.
2. Such disaster emergency requires state assistance to supplement local emergency management efforts to provide for public safety and the protection of property and to avert and lessen the threat and impact of the disaster.

**DECLARATION OF DISASTER EMERGENCY – 2021 Windstorm – 1**


3. The Kootenai County Board of Commissioners requests that the governor of the State of Idaho, together with other appropriate state officials, make such declarations, and provide assistance within Kootenai County, as is required and allowed by law.
4. The temporary disaster declaration by Chairman Fillios is hereby continued with the consent of the Kootenai County Board of Commissioners as found in Idaho Code Section 46-1011(1).


