

Resolution 2021-44
Kootenai County Waterways Ordinance Amendment to Honeysuckle Bay
No Wake Zone

WHEREAS, the Kootenai County Board of Commissioners (hereinafter referred to as “the Board”), pursuant to Idaho Code §31-807, is authorized to preserve, take care of, manage, and control county property; and

WHEREAS, the Board is empowered to enact ordinances necessary or proper to provide for the safety, promote the health and prosperity, improve the morals, peace and good order, comfort and convenience of the court and its inhabitants pursuant to IDAHO CONSTITUTION Article XII, section 2 and Idaho Code §§31-714 and 67-7031(3); and

WHEREAS, Idaho Code §67-7031(4) vests the Board of County Commissioners with the power and authority to adopt ordinances establishing operational zones for personal watercraft on any waters within its territorial limits, to include “no wake or less than five (5) miles per hour” zones; and

WHEREAS, the *Kootenai County Parks and Waterways Ordinance* provides for the codification of resolutions adopted by the Board of Commissioners as an appendix to the ordinance, Kootenai County Code, Section 6-2-21; and

WHEREAS, the Kootenai County Waterways Advisory Board has recommended an amendment to Kootenai County Code, Section 6-2-22, to amend the Restricted Zones section and adopt a no wake zone for Honeysuckle Bay, Hayden Lake; and

WHEREAS, it is the position of the Board that the recommendation of the Kootenai County Waterways Advisory Board appears reasonable and necessary to serve the betterment of its public facilities and benefit the residents of Kootenai County and the general public.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the following amended rule and regulation shall be, and is hereby adopted for Kootenai County parks and waterways facilities located in Kootenai County, Idaho, as defined in Title 6, Chapter 2, Kootenai County Code, as follows:

6-2-22: APPENDIX – REGULATION ADOPTED BY RESOLUTION:

A. Restricted Zones

1. No Wake Zones:

...

1. The posted areas on Honeysuckle Bay, Hayden Lake, to include the boat launch.

NOW THEREFORE, IT IS HEREBY RESOLVED, that the amendment to the Restricted Zone identified hereinabove shall be established and enforced, and that the instant Resolution be codified as an appendix to the *Kootenai County Parks and Waterways Ordinance* pursuant to Section 6-2-21.
