

RESOLUTION NO. 2020-45

**DONATION OF FOUR (4) TASER DEVICES TO SPIRIT LAKE
POLICE DEPARTMENT/KOOTENAI COUNTY SHERIFF'S OFFICE**

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

WHEREAS, *Idaho Code* §31-808 provides that property classified as being under \$250.00 may be sold through a private sale without notice of public auction; and

WHEREAS, the Kootenai County Sheriff's Office (hereinafter the "Sheriff") has in its possession four (4) Taser devices which were being utilized by the Sheriff as training devices for law enforcement officers. The four (4) Taser devices are identified by the following serial numbers: X00-607239, X00-589054, X00-471291, and X00-471278; and

WHEREAS, the Taser devices were purchased many years ago at a cost of approximately \$800 each but have depreciated over the years and have little or no present value; and

WHEREAS, the Taser devices are no longer manufactured or supported by the manufacturer, and the same are of no further use to the Sheriff and his law enforcement personnel; and

WHEREAS, it is the desire of the Sheriff to have the above referenced Taser devices declared as surplus property and then donated to the Spirit Lake Police Department for use by its law enforcement personnel.

NOW THEREFORE, IT IS HEREBY RESOLVED that the four (4) Taser devices referenced hereinabove be, and hereby are, declared to be surplus property, and in accordance therewith, the Board of County Commissioners may take action to dispose of said items in accordance with Idaho law.


IT IS FURTHER RESOLVED that the Board of County Commissioners consents to the donation of the four (4) Taser devices to the Spirit Lake Police Department.
