

Resolution 2020-91
Kootenai County Waterways Ordinance, Increase of Fees

WHEREAS, Sections 31-870 and 63-1311, Idaho Code, provide that the boards of county commissioners of each county in Idaho may collect fees for the services provided; and

WHEREAS, it is the responsibility of the Kootenai County Board of Commissioners, pursuant to Idaho Code §31-807, to manage the use of facilities owned by Kootenai County, which provide access to waterways and recreational opportunities; and

WHEREAS, Kootenai County Code 6-2-16(D) sets forth the authority of the Kootenai County Board of Commissioners to implement fees for the non-commercial use of county facilities; and

WHEREAS, the Kootenai County Waterways Advisory Board has recommended the following fee increases:

	Increased Fee Amount
Idaho Registered Boat, Annual Pass	\$40
Out of State Registered Boat, Annual Pass	\$100
Idaho Registered Boat, Day Use Pass	\$10/day
Out of State Registered Boat, Day Use Pass	\$20/day
Citation- Failure to pay launch fee	\$50
Idaho Resident, Annual Parking Pass	\$20
Out of State Resident, Annual Parking Pass	\$40
Idaho Resident, Day Parking Pass	\$5/day
Out of State Resident, Day Parking Pass	\$10/day
Citation- Failure to Pay Parking Fee, Idaho Resident	\$30
Citation- Failure to Pay Parking Fee, Out of State Resident	\$50
Citation-Parking Violation	\$50

NOW THEREFORE, BE IT HEREBY RESOLVED that the fees identified hereinabove shall become effective as of the date of adoption of this Resolution.


BE IT FURTHER RESOLVED that the fees adopted herein shall be administered by the Director of the Kootenai County Parks and Waterways Department.


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Duncan, seconded by Commissioner Brooks, the following vote was recorded:




