

**Resolution 2019-57
(Supersedes Resolution 2019-39)
District Court Fee/Auditor**

WHEREAS, *Idaho Code* §31-870 provides for the collection of fees by the Clerk of the District Court; and

WHEREAS, *Idaho Code* §31-870 also authorizes the Clerk of the District Court to collect fees reasonably related to, but not to exceed, the actual cost of the service being rendered; and

WHEREAS, District Court's case management system, Odyssey, is now capable of tracking partial payment plans, which under the former system were referred to an outside agency; and

WHEREAS, the Clerk of the District Court proposes administering a program for the in-house payment plans with a setup fee of \$12.50 to offset administrative expenses for the Court Clerk employees managing the program; and

WHEREAS, the Auditor's Office provided District Court an analysis of expenses in determining the proposed fee; and

WHEREAS, *Idaho Code* §31-710 authorizes the Board of County Commissioners to establish such fees;

NOW THEREFORE, IT IS HEREBY RESOLVED that a partial plan set up fee of \$12.50 shall be imposed by District Court effective June 25, 2019.


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Duncan, seconded by Commissioner Brooks, the following vote was recorded:






NOTICE OF PUBLIC HEARING




