

RESOLUTION NO. 2019-103
EXCHANGE OR TRADE-IN OF PERSONAL PROPERTY

WHEREAS, Idaho Code § 31-829 provides that whenever any elected official has any personal property belonging to the county under his jurisdiction or control which, in his judgment is obsolete, worn or damaged so as to require replacement and is of greater value on a trade-in or exchange for replacements than upon the sale as above permitted, he may, incident to purchase of such replacements and with the consent of the board of county commissioners, trade in or exchange such personal property and apply its trade-in or exchange value on the purchase price of replacements;

WHEREAS, the Kootenai County Assessor's Office has in its possession two vehicles, to-wit:

2004 Honda Pilot, VIN No. 2HKYF184X4H606414, Kootenai
County Asset Tag No. 6124

2006 Subaru Forester Wagon, VIN No. JF1SG65616G704542,
Kootenai County Asset Tag No. 6123

These vehicles are presently being utilized by the Assessor's Office personnel in the ordinary course and scope of business;

WHEREAS, the two vehicles described hereinabove have outlived their usefulness to the Kootenai County Assessor's Office, in that it is cost prohibitive to maintain and repair the vehicles in a safe, reliable condition, and the vehicles have been fully depreciated due to their age;

WHEREAS, the Kootenai County Assessor's Office desires to use the two vehicles described hereinabove as trade-ins for the purchase of one new 2020 Ford Explorer and one new 2020 Ford Escape through Mike White Ford of Coeur d'Alene, a local auto dealership, in that the 2004 Honda Pilot and the 2006 Subaru Forester Wagon have a greater value on trade-in than upon auction and/or private sale;

WHEREAS, Mike White Ford of Coeur d'Alene has offered to take the 2004 Honda Pilot and the 2006 Subaru Forester Wagon as trade-ins and apply the sum of \$2,500 for each vehicle as credit towards the purchase of one new 2020 Ford Explorer and one new 2020 Ford Escape;

WHEREAS, the Kootenai County Board of County Commissioners consent to the trade-in of the 2004 Honda Pilot and the 2006 Subaru Forester Wagon described hereinabove.


NOW, THEREFORE, BE IT RESOLVED that the Kootenai County Assessor's Office is hereby authorized to use the 2004 Honda Pilot and the 2006 Subaru Forester Wagon identified above as trade-ins for the purchase of one new 2020 Ford Explorer and one new 2020 Ford Escape through Mike White Ford of Coeur d'Alene.


