

RESOLUTION NO. 2023-66

Extension of Effective Dates for Approved Roster of Professional Consulting Service Providers (Originally Adopted via Resolution No. 2021-59)

WHEREAS, Idaho Code § 67-2320 declares that governmental entities in the state of Idaho shall make selections for professional engineering, architectural, landscape architecture, construction management, and professional land surveying services (collectively, “consulting services”) on the basis of qualifications and demonstrated competence and qualifications for the type of services required at fair and reasonable prices; and

WHEREAS, the Board of County Commissioners of Kootenai County issued a Request for Qualifications in October 2018 soliciting qualifications for consulting services pursuant to Idaho Code § 67-2320(2)(h); and

WHEREAS, the responding Statements of Qualifications included services for engineering design, architectural design, planning and plan review, evaluations, project management, construction management, contract administration, materials testing and surveying, inspection and quality control, fee and rate analysis, and report preparation; and

WHEREAS, Idaho Code § 67-2320(2)(j) allows any list established under paragraph (i) of that subsection to remain valid for a maximum of five (5) years; and

WHEREAS, the list prepared pursuant to the October 2018 solicitation set forth in Resolution No. 2021-59, entitled “Approved Roster of Professional Consulting Service Providers,” was due to expire on 31 December 2022; and

WHEREAS, the Kootenai County Board of Commissioners desires to extend the performance period of the promulgated list of pre-approved professionals in accordance with Idaho Code § 67-2320(2)(h);

NOW THEREFORE, BE IT HEREBY RESOLVED by the Board of County Commissioners of Kootenai County, Idaho that the list of professionals for consulting services set forth in Resolution No. 2021-59, entitled “Approved Roster of Professional Consulting Service Providers,” shall be, and is hereby effective retroactive to 1 January 2023 and shall remain effective through 31 December 2023 or as may be extended via subsequent resolution.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Brooks, seconded by Commissioner Duncan, the following vote was recorded:
