

RESOLUTION NO. 2017-51

TRANSFER AUTHORITY AND CONTROL OF THE HUMAN RESOURCES DEPARTMENT TO THE KOOTENAI COUNTY PROSECUTING ATTORNEY

WHEREAS, the Kootenai County Human Resources Department was previously established as a department of county government under the authority of the Legal Services Department; and

WHEREAS, in 2008, the Kootenai County Board of Commissioners ('Board') duly re-established the Human Resources Department as a stand-alone department under the oversight of the Board; and

WHEREAS, the supervision and control of County Risk Management operations was subsequently transferred from the Legal Services Department to the Human Resources Department pursuant to Resolution 2009-10; and

WHEREAS, the Board acknowledges the benefit in having the entirety of the Human Resources Department under the authority and control of the Kootenai County Prosecuting Attorney; and

WHEREAS, the Kootenai County Prosecuting Attorney has expressed his willingness to assume the duties of oversight and control over the Human Resources Department, and thereby relieve the Board of its duties in relation to Human Resources; and

WHEREAS, in an Elected Officials meeting held on Wednesday, May 17, 2017, the Elected Officials of Kootenai County voted unanimously in support of transferring oversight and control of the Human Resources Department to the Kootenai County Prosecuting Attorney, to support collaboration and increased efficiency of the department; and

WHEREAS, for the reasons stated above, the Board finds that it is necessary, desirable, and in the public interest for the authority and control over Human Resources to be transferred from the Board to the Kootenai County Prosecuting Attorney effective August 1, 2017;

NOW THEREFORE, BE IT HEREBY RESOLVED that authority and control over the Human Resources Department shall be and is hereby transferred from the Kootenai County Board of County Commissioners to the Kootenai County Prosecuting Attorney effective August 1, 2017.

BE IT FURTHER RESOLVED that, as of the effective date of this Resolution, the Kootenai County Board of County Commissioners do hereby approve the transfer of the Human Resources budget to the Kootenai County Prosecuting Attorney, and the transfer of all personnel and other assets necessary for the Prosecuting Attorney to

perform all duties related to the provision of the services of the Human Resources/Risk Management Department.

BE IT FURTHER RESOLVED that any conflicting prior resolutions or other prior actions of the Kootenai County Board of County Commissioners are hereby superseded, and that any such conflicting resolutions or other actions are hereby repealed.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Bingham, seconded by Commissioner Fillios, the following vote was recorded:
