WHEREAS, the Kootenai County Board of Commissioners are aware that the listed parcels in Exhibit "A" are under ownership of the County. Kootenai County, a government entity is tax exempt; therefore, the Commissioners' are requesting a cancellation of the taxes, penalties, interest and filing fees on the referenced parcels, record owner being Kootenai County, 451 N. Government Way, Coeur d'Alene, Kootenai County, ID; and

WHEREAS, Kootenai County Commissioners' requested that the taxes, penalties, interest and filing fees be cancelled on the referenced parcels for the outstanding balances listed individually within Exhibit "A" for the tax years through and including 2016 as the County has decided to keep the listed surplus properties and needs to perform a record clean up for accurate accounting; and

WHEREAS, the Kootenai County Board of Commissioners on June 9, 2017 at a properly noticed public meeting, agreed to cancel the outstanding balance of taxes, penalties, interest and filing fees excluding Aquifer and Forest Protection fees through and including 2016 tax years; and

NOW THEREFORE, IT IS RESOLVED that the outstanding balance of taxes, penalties, interest and filing fees for all tax years up to and including 2016 will be cancelled; and

BE IT FURTHER RESOLVED that the Treasurer and Assessor be directed to take appropriate action to effectuate said Resolution.


