**RESOLUTION NO. 2016-03**  
**Cancellation of Taxes, Interest and Penalties**  
**Worley Highway District**  
**Parcel No. 47No4W300670 / AIN 131595**

**WHEREAS**, the Kootenai County Board of Commissioners received a request for cancellation of taxes, penalties and interest on the referenced parcel number, record owner being the Worley Highway District, 12799 W. Ness Rd., Worley, Kootenai County, Idaho; and

**WHEREAS**, Kootenai County acquired certain real property via tax deed issued on April 13, 2004, and recorded as Instrument No. 1869843, Records of Kootenai County, Idaho, on April 14, 2004. The parcel number for the property is 47No4W-30-0670, and the alternate identification number (AIN) for the property is 131595. The property is legally described as set forth in Exhibit "A" attached hereto and incorporated by reference herein. This property was transferred to the Worley Highway District on the 27<sup>th</sup> day of May via Resolution 2014-42; and

**WHEREAS**, the record of owner is a tax exempt entity per Idaho Statute §63-602A; and

**WHEREAS**, the Kootenai County Board of Commissioners on January 6, 2016 at a properly noticed public meeting, agreed to cancel the taxes, penalties and interest for 2000, 2001, 2003, 2004 and 2005 and subsequent years; and

**NOW THEREFORE, BE IT HEREBY RESOLVED**, that the taxes, penalties and interest be cancelled for the 2000, 2001, 2003, 2004 and 2005 tax years and the taxes be adjusted to reflect the tax exemption for the 2000, 2001, 2003, 2004 and 2005 and subsequent years, on the referenced parcel owned by the Worley Highway District; and

**BE IT FURTHER RESOLVED**, that the Treasurer and Assessor be directed to take appropriate action to effectuate said Resolution.


