

**RESOLUTION NO. 2016-126**  
**Mowry State Park Overnight Camping User Fee**

**WHEREAS**, Sections 31-870 and 63-1311A, Idaho Code, provide that the boards of county commissioners of each county in Idaho may collect fees for services provided; and

**WHEREAS**, it is the responsibility of the Kootenai County Board of Commissioners to manage the use of facilities owned by Kootenai County, which provide access to waterways and recreational opportunities; and

**WHEREAS**, Kootenai County Code section 6-2-16(D) sets forth the authority of the Kootenai County Board of Commissioners to implement fees for the non-commercial use of county facilities; and

**WHEREAS**, Kootenai County manages Mowry State Park, Gasser Point, as a boat-in only facility and is authorized by the Idaho Department of Parks and Recreation to charge reasonable fees for the use of the facility by the public; and

**WHEREAS**, the Director of the Parks and Waterways Department, with the support of the Idaho Department of Parks and Recreation, has recommended that a \$10.00 per night overnight camping fee will be charged May 1<sup>st</sup> through October 1<sup>st</sup>, that a reservation can be made for a specific campsite for a one-time charge of \$10.00 (exclusive of the \$10.00 per night overnight camping fee), and that bundles firewood may be purchased for placement at a reserved campsite for \$10.00; and

**WHEREAS**, the Board of County Commissioners concurs with the fees recommended by the Director of Parks and Waterways Department;

**NOW THEREFORE, BE IT HEREBY RESOLVED** that the fees identified hereinabove shall become effective immediately.

**BE IT FURTHER RESOLVED** that the fees adopted herein shall be administered by the Director of Parks and Waterways.

Upon a motion to adopt the foregoing Resolution, made by Commissioner Stewart, and seconded by Commissioner Eberlein, the following vote was recorded:


