

**Resolution 2015-21**  
**Donate Surplus Vehicle to**  
**North Idaho Fair and Rodeo**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and,

**WHEREAS**, *Idaho Code* §31-808(9) vests the Board of County Commissioners with the power and authority to grant or exchange with the federal government, the state of Idaho, any political subdivision or taxing district of the State of Idaho, or any local historical society, with or without compensation, any real or personal property, if the same is in the public interest, and after proper notice has been published; and,

**WHEREAS**, *Idaho Code* §22-206 establishes the North Idaho Fair and Rodeo as a taxing unit funded in part by the Board of County Commissioners' ability to levy a tax pursuant to *Idaho Code* §31-823; and,

**WHEREAS**, pursuant to Resolution 2015-20, Kootenai County declared the following vehicle as surplus property:

1994 Chevrolet C1500 Cheyenne Pickup Truck, VIN No. 1GCEC14Z3RZ269596,  
Asset Tag No. 3429, valued at \$1,400.11; and,

**WHEREAS**, the above-described vehicle is not cost-efficient to maintain due to age and condition, and the North Idaho Fair and Rodeo has expressed an interest in obtaining the vehicle for use; and,

**WHEREAS**, Kootenai County resolved in Resolution 2015-20 that transferring/donating the above-described vehicle to the North Idaho Fair and Rodeo is in the public interest.

**NOW THEREFORE, IT IS HEREBY RESOLVED** that the Board of County Commissioners for Kootenai County does hereby authorize the transfer/donation of the vehicle referenced hereinabove, without consideration, to the North Idaho Fair and Rodeo pursuant to *Idaho Code* § 31-808(9), as such transfer is in the best interest of the public and the agencies involved.

**BE IT FURTHER RESOLVED** that prior to the transfer and/or donation of the above-referenced vehicle to the North Idaho Fair and Rodeo, the Board of County Commissioners shall cause to be published a notice of the transfer and/or donation in a newspaper in the county or having a general circulation in the county, pursuant to *Idaho Code* § 31-808(1).

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Green, seconded by Commissioner Eberlien, the following vote was recorded:




