

Resolution 2015-29
Criminal Background Fees/Concealed Weapons Permit Fees

WHEREAS, *Idaho Code* §18-3302 et. seq., provides for the collection of fees for issuance and renewal of concealed weapons permits by the sheriff for the purpose of enforcing the provisions of Chapter 33 of Title 18 of the Idaho Code, Firearms, Explosives and Other Deadly Weapons; and

WHEREAS, *Idaho Code* §18-3302 et. seq., also authorizes the sheriff to collect any additional fees necessary to cover the processing costs, and costs of materials in issuing the permits pursuant to this chapter; and

WHEREAS, there have been recent federal changes for Criminal Background Fees and current Fees for Concealed Weapons permits; and

WHEREAS, an update resolution is needed to reflect those changes; and

WHEREAS, *Idaho Code* §31-870 authorizes the Board of County Commissioners to establish such fees; and

NOW, THEREFORE, IT IS HEREBY RESOLVED that the following fee schedule for concealed weapons permits and criminal background fees shall be adopted effective March 2, 2015:


