

**Resolution 2014-86**  
**Surplus Equipment/Buildings & Grounds**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and,

**WHEREAS**, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

**WHEREAS**, Kootenai County Buildings & Grounds has on its asset list the following items, which due to age are obsolete and of no further use to the county and are lost and cannot be found after a diligent search:

- (1) Burster Model 2000, tag #2391 purchased 1995
- (2) Froen Extractor, MD700 tag #3561 purchased 1993
- (3) Toshiba Copier Model 2060 tag #3795 purchased 1999
- (4) Bosdoor wall mounted camera tag #4315 purchased 2006

**WHEREAS**, the estimated present value of these items is less than \$250.00 as they are obsolete and essentially valueless; and,

**WHEREAS**, Kootenai County Buildings & Grounds has not notified other county departments regarding the availability of these items as their whereabouts are unknown and the items are obsolete; and

**WHEREAS**, Kootenai County Buildings & Grounds desires to have the above-referenced items removed from the County's asset list;

**NOW THEREFORE, IT IS HEREBY ORDERED** that the items referenced hereinabove are valueless, obsolete, lost and shall be removed from the County's list of assets.


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Green, seconded by Commissioner Nelson, the following vote was recorded:


