

**Resolution 2014-88**  
**Surplus Equipment – Snowmobile Advisory Board**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and,

**WHEREAS**, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

**WHEREAS**, the Kootenai County Snowmobile Advisory Board has on its asset list the following items, which are of no further use to the county and have been exchanged for six (6) radios from the US Forest Service:

- (1) Big Country GE AMSTER II Repeater, Asset Tag #4049
- (2) ICOM U400 Communications Radio, Asset Tag #3380
- (3) ICOM U400 Communications Radio, Asset Tag #05118

**WHEREAS**, the estimated present value of these items is less than \$250.00 as they are obsolete and essentially valueless; and,

**WHEREAS**, the Kootenai County Snowmobile Advisory Board has not notified other county departments regarding the availability of these items, as they are no longer in possession of them; and

**WHEREAS**, the Kootenai County Snowmobile Advisory Board desires to have the above-referenced items removed from the County's asset list;

**NOW THEREFORE, IT IS HEREBY ORDERED** that the items referenced hereinabove are valueless, obsolete, and no longer in the county's possession and shall be removed from the County's list of assets.


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Nelson, seconded by Commissioner Green, the following vote was recorded:

Chairman Tondee:	Aye


