

Resolution 2014-93

**KOOTENAI COUNTY SHERIFF'S OFFICE/
EMPLOYMENT AGREEMENTS**

WHEREAS, the Kootenai County Board of County Commissioners enacted as a resolution, on the 21st day of October, 2008, Resolution 2008-103, resolving as follows:

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Kootenai County Commissioners hereby authorize the Kootenai County Sheriff's Department [Office] to enter into Employment Agreements in substantially the same form as the attached "Exhibit A" for reimbursement with new employees without the need to present those agreements individually to the Board through the public meeting process.

and,

WHEREAS, it is the desire of the Kootenai County Board of County Commissioners to ratify all Employment Agreements entered into by the Kootenai County Sheriff's Office, pursuant to Resolution 2008-103, and to authorize the Sheriff to send demand letters and file lawsuits to enforce the agreements, as necessary.

NOW THEREFORE, IT IS HEREBY RESOLVED that the Kootenai County Board of County Commissioners hereby ratifies all Employment Agreements entered into by the Kootenai County Sheriff's Office, pursuant to Resolution 2008-103.

IT IS FURTHER RESOLVED that the Kootenai County Sheriff is hereby authorized to enter into Employment Agreements in substantially the same form as the agreement attached hereto as Exhibit "A" for reimbursement with new employees, without the need to present those agreements individually to the Board through the public meeting process.

IT IS FURTHER RESOLVED that the Kootenai County Sheriff is hereby authorized to send demand letters and file lawsuits for the enforcement of Employment Agreements entered into with new employees, if necessary.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Green, seconded by Commissioner Nelson, the following vote was recorded:






