

Resolution No. 2014-97

Local Emergency Response Authority Change from Kootenai County Disaster Services
to
Fire Districts and Kootenai County Sheriff

WHEREAS, the Idaho Legislature enacted *Idaho Code* §39-7105(2), requiring counties to appoint a Local Emergency Response Authority for hazardous substance incidents occurring within the unincorporated area of the county; and,

WHEREAS, the Kootenai County Board of Commissioners, on the 22nd day of March, 1994, designated Kootenai County Disaster Services as the Local Emergency Response Authority for hazardous substance incidents occurring within the unincorporated areas of Kootenai County pursuant to Kootenai County Resolution 94-09.


NOW THEREFORE, BE IT HEREBY RESOLVED that Resolution Number 94-09 be rescinded, and that the Fire Districts having jurisdiction in Kootenai County, and the Kootenai County Sheriff when there is no Fire District with jurisdiction, are designated as the Local Emergency Response Authorities for hazardous substance incidents occurring within the unincorporated areas of Kootenai County.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Green, seconded by Commissioner Tondee, the following vote was recorded:


Commissioner Nelson: Absent


