

**Resolution 2013-64**  
**Surplus Property – GBC 5270 Laminator**  
**Kootenai County Reprographics**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power an authority to manage real and personal property for the benefit of the County; and,

**WHEREAS**, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners have the property declared as surplus and dispose of the property through sale or other means; and,

**WHEREAS**, *Idaho Code* §31-808 provides that property classified as being valued under \$250.00 may be sold through private sale without notice of public auction; and,

**WHEREAS**, Kootenai County Reprographics has in its possession (1) GBC 5270 Laminator, Serial #IHO2329, Model 5270 (asset tag #2367) which, due to age is obsolete and is of no further use to Reprographics; and

**WHEREAS**, the estimated present value of the recorder is less than \$250.00; and

**WHEREAS**, Kootenai County Reprographics has notified other county departments regarding the availability of the above referenced item but no representative of another county department has voiced an interest in, or requested the transfer of, said equipment for use by their department; and

**WHEREAS**, Kootenai County Reprographics desires to have the above-referenced item declared as surplus property;

**NOW, THEREFORE, IT IS HEREBY RESOLVED** that the item referenced hereinabove be and hereby is, declared to be surplus property, and in accordance therewith, the Board of County Commissioners may take action to dispose of said item by public or private sale, or by another means, in accordance with Idaho law.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Nelson, seconded by Commissioner Green, the following vote was recorded:


