

RESOLUTION 2013-74

WHEREAS, the Grant Management Office submitted an Amendment to the Kootenai County Multi-Jurisdictional All Hazard Mitigation Plan.

WHEREAS, projects may be added to the Kootenai County Multi-Jurisdictional All Hazard Mitigation Plan by gaining the written approval of that jurisdiction's official signatories and subsequently submitting the project to the Kootenai County of Office of Emergency Management for inclusion in the Plan; and

WHEREAS, the Kootenai County of Office Emergency Management notifies the Idaho State Bureau of Homeland Security of a change to the Kootenai County Multi-Jurisdictional All Hazard Mitigation Plan; and

WHEREAS, the Kootenai County Board of County Commissioners at a properly noticed public meeting on August 20, 2013, took action to approve the request, however the record was not adequate for its intended purposes and contained some misstatements; and

WHEREAS, it is the intent of the Kootenai County Board of County Commissioners to address the issue through this resolution and repeal the prior discussion and decision of August 20, 2013;

NOW THEREFORE, BE IT RESOLVED, that the Kootenai County Board of County Commissioners approved the request to add to Sections 5.6.3 East Central Kootenai County, subhead: Flooding, the additional text *Development in the floodplain of the lower channel of Wolf Lodge Creek has constrained the channel causing increased bedload resulting in channel aggradation, increased flooding, and bank erosion* and to Section 5.6.3 East Central Kootenai County, Mitigation Actions, subhead: Flooding, the additional text *Seek assistance to obtain a restoration design that facilitates proper channel function in the lower Wolf Lodge Creek watershed and Implement restoration of the lower Wolf Lodge Creek channel following the restoration design described above.*


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Green, seconded by Commissioner Nelson, the following vote was recorded:


