

**Resolution 2013-83**  
**Transferring Property to Post Falls Police Department**  
**and Anchorage Fire Department**  
**(Rescinding Resolution 2013-49)**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

**WHEREAS**, *Idaho Code* §31-808(9) vests the Board of County Commissioners with the power and authority to grant personal property to any political subdivision when such grant is within the public interest; and,

**WHEREAS**, the Kootenai County Sheriff's Office/9-1-1 has in its possession ten (10) Gold Elite radio console positions for the purpose of public safety; and

**WHEREAS**, the cumulative value of the equipment is estimated to be \$36,000.00; and

**WHEREAS**, the original system was purchased in 1993 and has received upgrades throughout 2012; and

**WHEREAS**, this equipment was used solely for public safety communications; and

**WHEREAS**, the Post Falls Police Department has agreed to purchase the equipment identified on Exhibit 'A' attached hereto for the purchase price of \$30,000.00; and

**WHEREAS**, the Anchorage (Alaska) Fire Department has agreed to purchase the equipment identified on Exhibit 'B' attached hereto for the purchase price of \$6,000.00; and

**WHEREAS**, pursuant to *Idaho Code* §31-808(9) proper notice has been published on October 28, 2013 and November 15, 2013 in the Coeur d' Alene Press;

**NOW THEREFORE, BE IT HEREBY RESOLVED** that the Kootenai County Board of Commissioners finds that the transfer of the above referenced equipment to the Post Falls Police Department and to the Anchorage Fire Department is in the public interest; that the transfer of the equipment will benefit the residents of Post Falls, Idaho and Anchorage, Alaska, respectively, and that such a transfer is in the interest of mutual cooperation between the entities.

**BE IT FURTHER RESOLVED** that Kootenai County hereby authorizes the transfer of the equipment identified on Exhibit 'A' attached hereto to the Post Falls Police Department, and also hereby authorizes the transfer of the equipment identified on Exhibit 'B' attached hereto to the Anchorage Fire Department, pursuant to *Idaho Code* §31-808(9).

**BE IT FURTHER RESOLVED** that Resolution No. 2013-49, adopted on June 25, 2013, is hereby rescinded and is of no further force or effect.


Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Nelson, seconded by Commissioner Green, the following vote was recorded:


