

## AGREEMENT TO PROVIDE LAW ENFORCEMENT SERVICES

THIS AGREEMENT, is made and entered into this ,21 day of August, 2025, between Kootenai County Sheriff's Office, and Kootenai County, a political subdivision of the State of Idaho (hereinafter collectively referred to as the "County") and Breakthrough T1D Ride (Juvenile Diabetes Research Foundation).

WHEREAS, the Breakthrough T1D Ride desires to enter into a contract with the County for the performance of additional law enforcement services to support the Breakthrough T1D Ride on September 27, 2025 from 06:00 – 17:00 hrs. (to include one hour travel time, for a total of 12 hours) to be held along the course on the attached map.

WHEREAS, the County agrees to render such services under the terms and conditions set forth herein.

NOW, THEREFORE, the parties hereto agree as follows:

1. **COST REIMBURSEMENT.** Breakthrough T1D Ride agrees to reimburse the County for any wages paid to the County's law enforcement personnel while engaged in law enforcement activities on behalf of the Breakthrough T1D Ride during sponsored events, as indicated below in section 2. The reimbursement shall be calculated at the deputy's overtime rate of pay, plus the costs of associated benefits. The parties agree that the County will calculate the hours of service provided by the County and provide the Breakthrough T1D Ride with a billing reflecting the amount owed for the preceding event.
2. **LAW ENFORCEMENT SERVICES.** The County agrees to employ, furnish, and supply TWO (2) uniformed deputies, together with their vehicles, equipment, supplies and supervision, and such other items as are reasonably necessary to provide law enforcement services, at the Breakthrough T1D Ride under the following terms and conditions:
  - (1) The County shall furnish TWO (2) uniformed deputies at the above listed event.
    - a. It is understood and agreed that in the event that a deputy makes an arrest while working at the event, that deputy may be required to physically leave the event to complete the arrest, and another deputy may not be dispatched to the event during the arresting deputy's absence.
    - b. It is understood and agreed that specific events scheduled during the above-described time periods may last longer than expected. The parties agree that in such event, the deputies will remain and provide law enforcement services at the event until such time as the event is over, the patrons have dispersed, and/or the Breakthrough T1D Ride have informed the deputies their services are no longer needed.
    - c. At the event, the deputy will be available to respond to calls regarding suspected criminal activity of patrons, both on the premises and on the public roadways in the general area of the Breakthrough T1D Ride, when necessary, during the hours indicated above, for the purpose of enforcing all laws of the State of Idaho and all applicable ordinances, and to preserve the peace on the premises and within the general area around the Breakthrough T1D Ride.

d. The presence of the County deputy will suggest the presence of law enforcement at the Breakthrough T1D Ride and serve as a deterrent for illegal activity on the premises and/or near the general area of the Breakthrough T1D Ride during the time periods referenced above. The Kootenai County Sheriff's Office, located at 2451 W. Dakota Ave. Hayden, Idaho 83835, will be used as an operations base for the services contemplated herein. In addition, the Deputy shall perform such community service tasks as may be necessary to aid in delivering such services to the patrons of the Breakthrough T1D Ride during the designated event.

e. Notwithstanding any provision in this Agreement, the parties understand and agree that the Sheriff may, in his sole discretion, divert the assigned personnel and equipment to other locations within Kootenai County in the event of an emergency or on occasion as service demands require.

f. The personnel used by the County to provide law enforcement services shall remain under the jurisdiction and control of the County while these services are being rendered. The County shall be responsible for setting and maintaining the standard of performance of such personnel.

g. The Breakthrough T1D Ride shall dedicate a parking space (s) near the entrance of the ride route for the County law enforcement vehicle (2).

3. GENERAL LIABILITY. The Breakthrough T1D Ride agrees to indemnify and hold the County harmless from any and all liability, loss, damage or claims, excluding that arising from the negligent or intentional acts of the County's officers, that it may suffer arising out of or in connection with the actions of the Breakthrough T1D Ride, its agents and employees, rendered pursuant to this Agreement. It is understood that the County law enforcement officers are not employees of the Breakthrough T1D Ride, and that the County is responsible for performance of the law enforcement services addressed thereby. Both parties agree to cooperate with the other to the greatest extent possible in the defense of any claim brought against either party.

4. INSURANCE. Both the County and the Breakthrough T1D Ride agree to obtain and keep in force during their performance under this Agreement a comprehensive general liability insurance policy in an amount not less than \$1,000,000.00. Such policies shall name and protect each respective party, all employees, officers, agents and employees, from and against claims, losses, actions, and judgments for damages or injury to persons or property arising out of or in connection with the acts of the Breakthrough T1D Ride or the County law enforcement officers pursuant to this Agreement.

5. TERM OF AGREEMENT. This Agreement shall be effective commencing on the 27th day of September, 2025. Either party may terminate this Agreement with 48 hours written notice.

6. GENERAL PROVISIONS. This Agreement represents the entire agreement of the parties hereto and supersedes all other contracts, oral agreements or any other memoranda. This Agreement may be modified only by a writing executed in the same form and manner as this Agreement has been executed. The terms and conditions of this Agreement shall be governed by the laws of the State of Idaho. Jurisdiction and venue for any legal action arising from the terms of this Agreement shall be in the District Court in Kootenai County, Idaho.

7. RECITALS. The above and foregoing recitals shall be considered a part of this Agreement for all purposes and interpretations.


