

**RESOLUTION NO. 2026-03**

**In the Matter of Establishing Election Precincts as Required by  
Idaho Code § 34-301**

WHEREAS, the Board of County Commissioners is required by Idaho Code § 34-301 to establish a convenient number of election precincts; and,

WHEREAS, Idaho Code § 34-301 requires this board action to be done no later than January 15<sup>th</sup> in a general election year; and,

WHEREAS, Kootenai County is seeking to maintain the existing precinct boundaries, previously adopted in 2025, for the 2026 election year;

NOW THEREFORE, IT IS HEREBY RESOLVED that the Kootenai County election precincts be established as shown on the attached maps, previously adopted in 2025, and numbered as follows:

Legislative District #2 – 201, 202, 203, 204, 205, 206, 207, 208, 209

Legislative District #3 – 301, 302, 303, 304, 305, 306, 307, 308, 309, 310, 311, 312, 313, 314, 315, 316, 317, 318, 319, 320, 321, 322, 323

Legislative District #4 - 401, 402, 403, 404, 405, 406, 407, 408, 409, 410, 411, 412, 413, 414, 415, 416, 417, 418, 419, 420

Legislative District #5 - 501, 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, 512, 513, 514, 515, 516, 517, 518, 519, 520, 521, 522

The established precincts shall be adopted this day; and,

BE IT FURTHER RESOLVED, that the Kootenai County Clerk and Auditor is hereby authorized to commence with all necessary speed to provide the Secretary of State with the required reports, maps and files concerning and describing the precincts established herein, pursuant to Secretary of State guidance and Idaho Code § 34-301.


