After conducting the requested evaluation of the current Commissioner Districts, and in line with the requirements of Idaho Code 31-704, we would like to recommend not making any population adjustments at this time. We would like to ask the Board to approve three map corrections. The reason for the corrections is explained below.

Change A on Exhibit 1: This change affects no habitable structures.

Change B on Exhibit 1

This change moves 29 Residential Units containing an estimated 65 people from District 2 into District 3. All parcels reside outside city limits. This change will make it so we don't split precinct 320 by Commissioner Districts.

Exhibit 2

This map shows two areas, located on the south side of the Spokane River which should be associated with District 2 instead of District 1. The error occurred due to an incorrectly drawn shoreline boundary that has since been corrected.


