

**Resolution No. 2026-09**  
**Sole Source Procurement of Replacement**  
**Elevator Components and Installation**

WHEREAS, the Kootenai County Board of Commissioners (“the Board”) is charged with the duty and responsibility to ensure that its buildings are safe for its elected officials, employees, and the public; and

WHEREAS, the elevator located in the Kootenai County Juvenile Justice Center will soon be at the end of its functional life unless replacement components are procured and installed;

WHEREAS, the Board desires to secure an agreement to obtain replacement elevator components and installation for the ThyssenKrupp (TK) elevator located in the Juvenile Justice Center; and

WHEREAS, pursuant to Idaho Code § 67-2808(2), the Board is permitted to use sole source procurement where the compatibility of equipment, components, accessories, computer software, replacement parts, or service is the paramount consideration;

WHEREAS, the Board hereby finds and declares that the paramount considerations for procurement of replacement elevator components and installation from TK Elevator for the ThyssenKrupp (TK) elevator located in the Juvenile Justice Center are compatibility of equipment, components, replacement parts, and service; and

WHEREAS, pursuant to Idaho Code § 67-2808(2), the Board is permitted to use sole source procurement for the purchase of public works construction, services or personal property for which it is determined that there is no functional equivalent; and

WHEREAS, after diligent search, the Board has determined that no functional equivalent to TK Elevator replacement components and installation exists; and

WHEREAS, pursuant to Idaho Code § 67-2808(2), the Board is permitted to use sole source procurement where competitive solicitation is impractical, disadvantageous or unreasonable under the circumstances; and

WHEREAS, it appears that TK Elevator is the sole source of replacement components and installation for TK and ThyssenKrupp elevators;

NOW THEREFORE, BE IT HEREBY RESOLVED that the Board does hereby intend to contract with TK Elevator as the sole source vendor to provide elevator components and installation for the ThyssenKrupp (TK) elevator located in the Juvenile Justice Center.
