This notice and agreement is to inform you of the fee structure that applies to all commercial solid waste accounts, including residential customers receiving services of greater than a one (1) yard container within Kootenai County.

There are two (2) separate fees/ bills associated with this service:

1. A fee charged by the company providing the container and hauling service.
2. A fee charged for disposal of waste by the hauler to a Kootenai County Transfer Station for disposal into the landfill, rates are subject to change without notice. The Solid Waste Fee Resolution is available at the website: www.kcgov.us/departments/solidwaste

Services within the **City Limits of Coeur d'Alene** are included on one invoice, generated monthly by the City of Coeur d'Alene. (Duplicate notices & statements not available in the City of Coeur d'Alene)

Services **outside of the City Limits of Coeur d'Alene** are **SEPARATELY BILLED** monthly by **the hauling company AND Kootenai County**.

Pursuant to the provisions of Title 4 Chapter 3 of Kootenai County Code, which can be accessed on our website www.kcgov.us, charges for the disposal of solid waste WILL remain the liability of the property owner. I, the property owner, authorize Kootenai County Solid Waste to set up an account to be activated for the tenant and the billing to be sent to the tenant for the property address listed below.
