To apply for credit, please complete and return the attached Commercial Credit Application to the address or fax number listed on the application.

Accounts will not be opened without complete information and an authorized signature on application.

You will be notified when the application has been approved or declined.

CREDIT POLICIES:

- ❖ Minimum of 2 years in business.
- ❖ Your driver will receive an invoice for each load delivered. These invoices should be turned in to your A/P Department to verify with your monthly statement.
- ❖ Statements are mailed at the middle of the month.

MANNER OF PAYMENT:

Payment is due as follows:

- ❖ Payment in full is due 14 days from Statement's Bill Date.
- ❖ Include a copy of your Statement Remittance with your payment, or have your Kootenai County Solid Waste Account # on your Check Remittance.
