

Resolution 2018-50
Exchange/Transfer of Property to Spirit Lake Police Department

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and,

WHEREAS, *Idaho Code* §31-808(9) vests the Board of County Commissioners with the power and authority to grant or exchange with the federal government, the state of Idaho, any political subdivision or taxing district of the State of Idaho, or any local historical society, with or without compensation, any real or personal property, if the same is in the public interest, and after proper notice has been published;

WHEREAS, the Kootenai County Sheriff's Office has in its possession surplus law enforcement equipment which is not presently being utilized, i.e., one front and one rear vehicle partition and one SUV back seat insert, collectively purchased for the sum of approximately \$1,320. This equipment has been in reserve after being removed from dismantled fleet vehicles; and,

WHEREAS, the Spirit Lake Police Department has in its possession a half canine kennel and associated fans, temperature sensors and window covering, all of which had been installed in one of its patrol SUVs, but is no longer of use to the Department. The approximate replacement value of the kennel and associated equipment is \$2,300; and,

WHEREAS, the agencies referenced above have expressed a desire to exchange the law enforcement equipment for the canine kennel and associated equipment. Such exchange would result in a monetary savings to Kootenai County and benefit the everyday operations of the agencies involved.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Kootenai County Board of Commissioners authorizes the transfer of the law enforcement equipment by the Kootenai County Sheriff's Office to the Spirit Lake Police Department, in exchange for the transfer of the canine kennel and associated equipment from the Spirit Lake Police Department for the use and benefit of the Kootenai County Sheriff's Office, pursuant to *Idaho Code* §31-808(9). Such transfer/exchange of property is to be made without consideration and is in the best interest of the public and the agencies involved.

BE IT FURTHER RESOLVED that prior to the transfer/exchange of the above-referenced property with the City of Spirit Lake Police Department, the Kootenai County Board of County Commissioners shall cause to be published a notice of the transfer/exchange in a newspaper in the county, or having a general circulation in the county, pursuant to *Idaho Code* § 31-808(1).

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Fillios, seconded by Commissioner Bingham, the following vote was recorded:
