

## **Resolution 2016-72**

### **George Anderl Memorial Park (Re-naming of Loch Haven Park)**

**WHEREAS**, the Kootenai County Board of Commissioners (hereinafter referred to as “the Board”), pursuant to Idaho Code §31-806, is authorized to hold, maintain, improve, and operate property it has acquired for the use and purpose of a public park or public recreation; and

**WHEREAS**, Kootenai County owns certain public park property, commonly known as Loch Haven Park, at 2236 E. Loch Haven Drive in Hayden, Kootenai County, Idaho, which property’s Parcel Number is 51N03W-19-6175 and AIN is 141365; and

**WHEREAS**, Kootenai County holds all right, title, and interest in fee simple to the property, which is legally described as follows:

That unplatted portion of Government Lot 4, Section 19, Township 51 North, Range 3 West, Boise Meridian, Kootenai County, Idaho, bordered on the west by the west line of said Government Lot 4; bordered on the north by the north line of said Government Lot 4; bordered on the northeast by the southwesterly right-of-way line of Loch Haven Drive; bordered on the east by Block A of the Plat of Hayden View Estates and Lot 5, Block 4 of the Plat of Woodland Heights First Addition; bordered on the southeast by Lots 2, 3 and 4, Block 4, Plat of Woodland Heights First Addition; and bordered on the south by Lots 2, 3 and 4, Block 3, and Lot 1, Block 4, said Plat of Woodland Heights First Addition.

Excepting therefrom that certain parcel belonging to the Dalton Water Association described as: Beginning at the Northwest corner of the Southwest ¼ of the Southwest ¼ of said Section 19; thence South 190.5 feet along the west line of said Southwest ¼ of the Southwest ¼ of Section 19; thence North 69°20’ East, 187 feet; thence North 20°40’ West, 50 feet; thence North 69°20’ East, 197 feet, more-or-less, to the north line of said Southwest ¼ of the Southwest ¼ of Section 19; thence west 342 feet, more-or-less, to the Point of Beginning.

And containing a net acreage of 10.0 acres, more-or-less, exclusive of the Dalton Water Association parcel.

**WHEREAS**, the Board desires to rename the public park property as George Anderl Memorial Park.

**NOW THEREFORE, IT IS HEREBY RESOLVED**, that the public park property commonly known as Loch Haven Park shall henceforth be known as George Anderl Memorial Park. Said name change shall be recorded in the Kootenai County Recorder’s Office.
