

Resolution 2016-73
Donation of Remington 870 Youth .20 Gauge Shotgun/Kootenai County
Sheriff's Office/North Idaho Violent Crimes Task Force

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

WHEREAS, *Idaho Code* §31-808 provides that property classified as being under \$250.00 may be sold through a private sale without notice of public auction; and

WHEREAS, the Kootenai County Sheriff's Office/North Idaho Violent Crimes Task Force (hereinafter the "Sheriff") has in its possession a Remington 870 Youth .20 Gauge Shotgun, Serial No. AB433413U, which was confiscated as a result of illegal drug activity; and

WHEREAS, after performing due diligence, the Sheriff was unable to trace the serial number and/or locate the registered owner of the shotgun;

WHEREAS, at the request of the Sheriff, a local gun dealer performed an appraisal of the shotgun and declared that the shotgun's present retail value was somewhere between \$135 and \$155; and

WHEREAS, the shotgun referenced hereinabove is in fair/good condition but is not functional for the needs of law enforcement personnel; and

WHEREAS, Coeur d' Alene Skeet & Trap, a local non-profit organization, sponsors a youth shooting team known as The Hayden Long Shots. The team is comprised of local youth having an interest in learning responsibility, teamwork, dedication, and proper gun safety Coeur d' Alene Skeet & Trap has expressed an interest in the shotgun for use by its youth team members; and

WHEREAS, it is the desire of the Sheriff to have the above referenced shotgun declared as surplus property and then donated to Coeur d' Alene Skeet & Trap for use by its youth shooting team.

NOW THEREFORE, IT IS HEREBY RESOLVED that the shotgun referenced hereinabove be, and hereby is, declared to be surplus property, and in accordance therewith, the Board of County Commissioner may take action to dispose of said item in accordance with Idaho law.
