

Resolution 2012-65
Surplus Vehicles/Sheriff's Department

WHEREAS, *Idaho Code* §31-808 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* 31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioner, have the property declared as surplus and dispose of the property through sale or other means; and,

WHEREAS the Kootenai County Sheriff's Department has in its possession the following vehicles:

NOW THEREFORE, IT IS HEREBY RESOLVED, that the vehicles described hereinabove be, and hereby are, declared to be surplus property, and, in accordance therewith, said vehicles shall be sold at public auction to the highest bidder in accordance with *Idaho Code* § 31-808.
