

Resolution 2012-49
Concealed Weapons Permit Fees

WHEREAS, *Idaho Code* §18-3302 provides for the collection of fees for issuance and renewal of concealed weapons permits by the sheriff for the purpose of enforcing the provisions of Chapter 33 of Title 18 of the Idaho Code, Firearms, Explosives and Other Deadly Weapons; and

WHEREAS, *Idaho Code* §18-3302 also authorizes the sheriff to collect any additional fees necessary to cover the processing costs and costs of materials in issuing the permits pursuant to this chapter; and

WHEREAS, the Kootenai County Board of Commissioners has determined it necessary and in the best interest of the residents of Kootenai County to establish the amount of these fees by resolution; and

WHEREAS, *Idaho Code* §31-870 authorizes the Board of County Commissioners to establish such fees; and

NOW, THEREFORE, IT IS HEREBY RESOLVED that the following fee schedule for concealed weapons permits shall be adopted effective May 1, 2012:

NEW PERMITS:

- \$20.00 fee for original issuance of a five-year permit
- \$34.00 fee for criminal background check
- \$ 5.00 fee for the permit itself and reminder mailer

RENEWAL PERMITS:

- \$15.00 fee for the renewal of the permit
- \$ 5.00 fee for updated criminal background check
- \$ 5.00 fee for the permit itself and reminder mailer

RENEWAL PERMITS ISSUED 91 DAYS AFTER THE EXPIRATION OF THE MOST RECENT PERMIT BUT LESS THAN TWO YEARS AFTER THE EXPIRATION OF THE MOST RECENT PERMIT:

- \$15.00 fee for the renewal of the permit
- \$10.00 late renewal penalty in addition to the renewal fee
- \$ 5.00 fee for the updated criminal background check
- \$ 5.00 fee for the permit itself and reminder mailer

PERMIT RENEWALS APPLICATION AFTER TWO (2) YEARS PAST THE EXPIRATION OF THE MOST RECENT PERMIT WILL BE CHARGED AND PROCESSED AS A NEW PERMIT.

DUPLICATE PERMITS:

\$ 4.00 fee for the permit itself
