

Resolution 2012-105
Kootenai County Adult Misdemeanor Probation Fees

WHEREAS, the Kootenai County Board of Commissioners, acting in its capacity as the governing board of Kootenai County Adult Misdemeanor Probation, is authorized under *Idaho Code* §§31-3201D, 20-225, and 19-2608 (Senate Bill 1340) to set fees for probation services, and to set requirements for supervised probationers to pay for drug and alcohol testing fees (in addition to supervised probation fees) within Kootenai County and;

WHEREAS, legal notice was published, and a public hearing was held as required per Idaho Code 63-1311A on October 23, 2012 at its regularly scheduled time of 2:00 p.m., and;

WHEREAS, it is the desire of the Board of Commissioners that the Kootenai County Adult Misdemeanor Probation Department continue to be supported, to the extent possible, by collecting user fees for probation supervision and drug/alcohol/mental health treatment and testing including costs associated with S.C.R.A.M. and/or GPS monitoring, as determined in the attached schedule and;

WHEREAS, it will be the responsibility of the Kootenai County Adult Misdemeanor Probation Department to monitor, track, and collect any fees associated with supervision and drug/alcohol/mental health treatment and testing, including costs associated with S.C.R.A.M. and/or GPS monitoring, and as ordered paid pursuant to Administrative Order H12-K001 and as otherwise authorized by Idaho law;

NOW THEREFORE, BE IT HEREBY RESOLVED that the rates/fees be approved as follows:

Probation Fee	Not to exceed \$75.00 per month
Late Appointment fee	\$10.00 per late appointment
Missed Appointment fee	\$10.00 per missed appointment
SCRAM Wireless fee	Not to exceed \$10.50 per day
SCRAM Non-Wireless fee	Not to exceed \$8.50 per day
GPS	\$15.00 per day
Stalker Alert	\$4.00 per day
Drug Testing fee	\$5.00 per test
Breathalyzer fee	\$.25 per test
