

RESOLUTION 2012-

Kootenai County Courthouse Campus Facilities Management

(This Resolution Supersedes Resolution No. 96-06)

WHEREAS, the Kootenai County Board of Commissioners, the Kootenai County Prosecutor, the Kootenai County Assessor, the Kootenai County Clerk, the Kootenai County Treasurer, as well as Judges and judicial staff for the First Judicial District of the State of Idaho, maintain their offices in the Kootenai County Courthouse Campus located at 451 N. Government Way, 324 West Garden Ave and 501 Government Way, Coeur d'Alene, Idaho; and,

WHEREAS, the Kootenai County Board of Commissioners have the power pursuant to *Idaho Code* §31-604(4) to make such orders for the use of its property as the interests of its inhabitants require; and,

WHEREAS, the Kootenai County Board of Commissioners have the power pursuant to *Idaho Code* §31-807 to control and manage county property; and,

WHEREAS, the Kootenai County Board of Commissioners are charged pursuant to *Idaho Code* §1-1613 and §1-2217 with providing and maintaining suitable adequate facilities for the district court and magistrate court within the county; and,

WHEREAS, the Kootenai County Board of Commissioners have the duty to ensure that Kootenai County can reasonably preserve the Kootenai County Courthouse Campus for the uses to which the Kootenai County Courthouse Campus is dedicated and to preserve the normal functioning of the government activities which occur within the Kootenai County Courthouse Campus.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Commissioners of Kootenai County as follows:

- ❖ Loitering, disturbing the peace, creating noise or nuisance, or conduct which obstructs, or inhibits the flow of pedestrian traffic in the entrance, foyers, lobbies, corridors, and offices shall be prohibited in the Kootenai County Courthouse Campus.
- ❖ There shall be no parades, processions, or assemblages in the Kootenai County Courthouse Campus or entrances thereto, nor any display therein of any flag, banner, placard, or device designed to bring into public notice any party, organization or movement.
- ❖ The flags and seals of the United States, State of Idaho and Kootenai County shall be permitted within the Kootenai County Courthouse Campus.

- ❖ There shall be no solicitation, commercial advertising or posting, distributing, displaying or affixing of any pamphlets, handbills, flyers or notices within the Kootenai County Courthouse Campus. This prohibition shall not apply to notices which are required by law to be publicly posted or notices which pertain to Kootenai County business.
