

**RESOLUTION NO. 2011- 79**  
**KOOTENAI COUNTY SOLID WASTE - SURPLUS PROPERTY**

**WHEREAS**, Idaho Code §31-808 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

**WHEREAS**, Idaho Code §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and,

**WHEREAS**, the Kootenai County Solid Waste Department is in possession of two transfer trailers, i.e., a 1991 ACE Transfer Trailer, VIN No. 1A9230061M0074591, and, a 1993 Alloy Transfer Trailer, VIN No. 1ALSL8287PS931268, which are of no further use to the department; and,

**WHEREAS**, each of the transfer trailers described hereinabove has a value in excess of \$250; and,

**WHEREAS**, on July 21, 2011, the Solid Waste Department notified other county departments via email regarding the availability of the transfer trailers referenced hereinabove but has received no request for the transfer of said trailers; and,

**WHEREAS**, the Solid Waste Department desires to have the transfer trailers declared as surplus property.

**NOW THEREFORE**, it is hereby resolved that the transfer trailers described hereinabove be, and hereby are, declared to be surplus property, and, in accordance therewith, the Board of County Commissioners may take action to sell the transfer trailers through public auction to the highest bidder, and if not sold at said public auction, then may dispose of said transfer trailers through private sale or other means in accordance with Idaho Code § 31-808.
