

RESOLUTION 2011-55  
Authorizing Office of Emergency Management Manager  
Volunteer Program Agreements

WHEREAS, the Board of County Commissioners is the governing board of the Kootenai County Office of Emergency Management, a department established under the authority and control of the Board, as defined in Idaho Code 46-1009 (Chapter 10, Title 46, Idaho Preparedness Act of 1975);

WHEREAS, several times each year the Office of Emergency Management enters into Volunteer Program Agreements with Kootenai County citizens to assist in the Kootenai County Office of Emergency Management (OEM) and the Emergency Operations Center (EOC);

WHEREAS, the Office of Emergency Management Manager presents to the Board for its approval through formal public meeting process each Office of Emergency Management Volunteer Program Agreement it enters into with Kootenai County citizens for volunteering in the OEM and the EOC;

WHEREAS, to expedite the approval process and avoid having to utilize the formal public meeting process concerning each Office of Emergency Management Volunteer Program Agreement presented, it would be beneficial to the Board and to the public to allow the Manager of the Office of Emergency Management to sign the Volunteer Program Agreements;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of County Commissioners hereby delegates to the Manager of the Kootenai County Office of Emergency Management the authority to review and execute all Office of Emergency Management Volunteer Program Agreements.

BE IT FURTHER RESOLVED that such delegation shall not be construed as a relinquishment of the ultimate authority of the Board of County Commissioners in matters involving the Kootenai County Office of Emergency Management.

BE IT FURTHER RESOLVED that this action may be modified or rescinded at any time by subsequent resolution of the Board.

BE IT FURTHER RESOLVED that any conflicting prior resolutions are hereby superseded and such conflicting provisions repealed.
